## 9. Criteria for admission to the programme

Admission is assessed through the submission of a CV and application materials. Students must have a minimum of 3 years professional experience, post undergraduate or equivalent experiential learning, in their field of arts practice. They must maintain an active professional practice while enrolled on the MA, this need not be paid work, but students need to remain engaged with their professional practice.

Students may hold an undergraduate degree, and/or professional diploma though this is not an entry requirement for the MA programme. The student's suitability for study is assessed

at interview where their professional practice is discussed in terms of their CV in relation to the RPL claim they will make in the first year of MA study.

Students holding a PCGE/Level 7 qualification from the ISTD will have 60 credits at level 7 to accredit on entry and will undertake a lighter RPL process (worth 30 credits)

## 10. Aims of the programme

The programme aims to:

- 1. To nurture and enhance the professional practice of the student with direct relevance to the culture of their work-environment and to the wider field of dance/arts practice.
- 2. To offer validation and personal growth through accreditation of prior experiential learning, recognizing the contribution of practice to academic study.
- 3. To establish strategies for students' further contribution and articulation of knowledge to the field of dance/arts practice.
- 4. To cultivate reflective practice and critical thinking as catalysts for on-going professional development, transformation and contribution to the field of dance/arts practice.
- 5. To establish competence with research techniques, particularly qualitative research frameworks and methodologies in practice-based paradigms.
- 6. To analyse ethical interrogation of professional practice contexts.
- 7. To foster a vibrant and communicative community of dance/arts practitioners internationally via online learning.

#### 11. Programme outcomes\*

#### A. Knowledge and understanding

On completion of this programme the successful student will have knowledge and understanding of:

**A1:** A range of advanced reflective practice theories, and approaches to in-depth critical thinking within the dance/arts sector.

**A2:** complex ethical principles emerging from dance/arts theories and in synthesis with practical experiences.

**A3:** existing dance/arts practice and scholarship, identification of specialised knowledge which contributes the potential for transformation and original application of theoretical frameworks within their own practice.

## **Teaching/learning methods**

Students gain knowledge and understanding through engaging with online e-learning resources, on-line real-time discussion groups, asynchronous peer discussion using blogs, and tutor supervision.

## **Assessment methods**

Students' knowledge and understanding is assessed by their active engagement with online learning, communication through blogs, and commitment to sharing theory through professional practice in the wider community. Students demonstrate their Knowledge and Understanding through critical thinking demonstrated within the work submitted for grading at the end of each module.

#### B. Skills

On completion of this programme the successful student will be able to:

- **B1**: Professionally network and communicate in an autonomous manner across practice-based and academic settings at an advanced level.
- **B2:** To demonstrate expertise in managing, synthesising, and contextualising information in the design, development, and articulation of learning through critical frameworks within professional dance/arts contexts.
- **B3:** Carry out an advanced practice-based research project, working autonomously to consider originality in questions that emerge from dance/arts practice. Critically articulate processes and findings from research through relevant formats for a range of stakeholders.

## Teaching/learning methods

Students learn skills through suggested tasks and readings outlined in the Module Handbooks, online discussion groups, independent research, and through supervision support. Practical skills are further developed through application of theory and experiences in the student's wider community of practice.

#### **Assessment methods**

Students' skills are assessed through their engagement with critical reflection on, and evidenced understanding of, their wider professional context particularly through the dissemination of their research project via academic essay, professional artefact, and viva with supporting evidence of discussion through related on-line activity such as blog posting.
