#### 9. Criteria for admission to the programme

- 2<sup>nd</sup> class or above honours degree in a relevant discipline; or
- 2<sup>nd</sup> class or above honours degree in any discipline plus relevant work experience; or
- An equivalent qualification acceptable to the Academic Registry of the University
- A minimum of three years relevant voluntary or professional experience, and other professional gualifications. These applications are considered on an individual basis.

Those without formal qualifications are welcome to apply and may be required to attend an interview. Additionally, such applicants will need to provide evidence of a minimum of three years relevant experience at middle to senior management level.

International applicants whose first language is not English must prove competence to study at post-graduate level in English. Normally this will involve certification of competence of IELTS (with minimum 6.0 with minimum 6.0 in Reading and Writing and minimum 5.5 in Listening and Speaking) or equivalent.

#### 10. Aims of the programme

The programme aims to:

- 1. Provide students with in depth knowledge of evolving theoretical and conceptual, governance and policy debates within the field of sustainable development.
- 2. Develop students' systematic critical awareness of the complexities that inhibit the ability of national and international policies to effectively address global challenges such as climate change and poverty.
- 3. Provide an intellectual setting in which students can develop appreciation of substantive issues in relation to processes of governance and public policy formulation in different societies and contexts.
- 4. Develop critical understanding of notions such as sustainability, social justice, and rights.
- 5. Enhance opportunities for senior/managerial level employment through advanced intellectual, communication, technological and work related skills.
- 6. Provide students with a multi-disciplinary understanding of the changing trends in sustainable development.
- 7. Foster students' ability to collect, analyse and interpret information on key issues related to their programme of study and to use this to construct reasoned, evidenced argument.
- 8. Apply research, policy, legislation and best practice principles to complex situations relevant to their own area of work or career aspirations through a substantial piece of independent study.
- 9. Demonstrate knowledge and apply current theories and practices related to business or policy practises, critically assess and interpret relevant organisational and external data to assist the organisation in its understanding of problems or opportunities in the relevant field of study and evaluate and apply relevant theories and models to arrive at practical solutions for a real-life organisation and the relevant policy context

The programme recognises that students are future and career-focused, looking to develop and enhance their skills for employment in various project and policy positions. Consequently, a vital tenet of the programme is the focus on experiential-based learning and practical, hands-on application of knowledge. This is reflected in the programme's

overall design and the range of innovative and practitioner-oriented core and optional modules.

The experiential focus of the programme will equip students with differing levels of governance knowledge to develop an advanced level of understanding and critical reflection on key governance and sustainable development concepts and policies.

#### 11. Programme outcomes

#### A. Knowledge and understanding

On completion of this programme the successful student will have knowledge and understanding of:

- A1 a broad range of different theorisations, principles and manifestations of sustainable development in a global context
- A2 the notion of global governance and its critique
- A3 the notions of rights, social justice, equality and inclusion and their implications for governance
- A4 the global governance actors and the factors that influence their remits and scope for action in devising and implementing governance solutions for key sustainable development issues
- A5 global governance issues such as poverty, climate change, food security and gender and minority rights and demonstrate an understanding of the complexity of addressing these at different governance scales
- A6 implications for international relations of forces of globalisation, the rise of international organisations and transnational politics.

#### Teaching/learning methods

Students gain knowledge and understanding through a programme of lectures and seminars in core modules. Students will complement generic knowledge of governance and public policy with in-depth specialist knowledge through their choice of optional module and a research dissertation or a work based learning project. Teaching methods are designed to facilitate independent study and development as autonomous learners and to support the acquisition of employability skills.

#### Assessment methods

Students' knowledge and understanding is assessed by a variety of assessment methods including essays, reports, reviews and a research proposal. The range of coursework submissions allows students to demonstrate their understanding of theory and practice and their ability to sustain a coherent argument.

#### B. Skills

On completion of this programme the successful student will be able to:

- B1 Systematically analyse drivers for and manifestations of sustainable development issues at a range of governance scales to identify appropriate governance responses
- B2 Devise evaluation criteria and apply these to governance and policy approaches centred on key global governance issues
- B3 Contrast and compare the different epistemological and ontological foundations of evidence and knowledge generation in relation to key sustainable governance issues
- B4 Outline and evaluate the strengths and weaknesses (including ethical implications) of different research methodologies and methods in a chosen research or work-based development project

- B5 Develop in-depth expertise in a chosen area of sustainable development and identify personal strengths, knowledge and skills to market to potential employers.
- B6 Engage in reflective practice, relating studies to career and personal development.
- B7 Plan and carry out an independent research project, policy evaluation or work-based development project
- B8 Engage in reflective practice, relating studies to career and personal development and display practical capabilities in analytics data gathering, analysis, interpretation of data and evaluating governance performance;

#### Teaching/learning methods

Students learn skills progressively throughout the programme within the core modules (skills 1 - 3) and within the research methods module (skills 4 - 5). These skills are developed through computer-based exercises, workshops, interactive learning using Moodle (a blended learning aspect) and preparation for and delivery of presentations. The skills-based assessment methods give students the opportunity to apply the knowledge learnt in lecture sessions to real life scenarios from their chosen specialism and help them develop their subject specific practical, problem solving skills. Formative assessment is used to scaffold the transition from knowledge acquisition to application and evaluation. Those students who chose to take an integrated lea work placement and produce a project report will have further opportunity to enhance their practical skills. The dissertation project and the 12 month Business Transformation Project (If the student is registered on the placement version of the programme) modules will support the development of skills 4-8.

#### Assessment methods

Students' practical skills are assessed by a variety of methods. Students are given the opportunity to demonstrate skills 1 - 3 in a variety of modules through workshop exercises and through diverse formative and summative assessments. Skills 4 - 8 are best demonstrated by an independent research dissertation and by the successful completion of the 12-month work placement or Business or Policy Transformation Project.

#### 12. Programme structure (levels, modules, credits and progression requirements)

#### 12. 1 Overall structure of the programme

The programme is structure to accommodate both full-time study, which may include an opportunity of professional experience for 12 months for students studying at the London campus, and part-time enrolment. The programme has two entry points: September and January. Full time MA students will take 120 credits consisting of 6 taught modules of 20 credits each over the first academic year plus undertake a dissertation for a further 60 credits.

Full-time students on the Professional Experience version of the programme will take the 12-month non-credit bearing Postgraduate Placement module in year two in order to gain the qualification titled MA/PGDip/PGCert Global Governance and Sustainable Development with Professional Experience.

In the event of a student being unsuccessful in securing a 12-month postgraduate placement or chooses not to progress to that route, the student may undertake the Business Transformation Project module. Alternatively, the student may exit after

completing year one with a MA Global Governance and Sustainable Development award providing they have, or can complete, sufficient credits (120 including SSC4994 Dissertation).

- Students intending to progress to the year Professional Experience are not permitted to take SSC4031 Integrated Work and Learning OR SSC4060 Work Integrated Learning (a 60 credit alternative to SSC4994 Dissertation)
- Students cannot take both SSC4031 Integrated Work and Learning OR SSC4060 Work Integrated Learning (a 60 credit alternative to SSC4994 Dissertation). It is a barred combination.

#### PROGRESSION REQUIREMENTS

Students may advance to the project stage with a maximum of a 30 credit deficit

Students on the MA Global Governance and Sustainable Development with Professional Experience are required to have successfully pass ALL taught modules in order to progress to the postgraduate placement modules

#### 14. Placement opportunities, requirements and support (if applicable)

Professional experience is offered as an opportunity for full time students studying at the London campus. If students have registered on the 24 month professional experience programme, they will have the option to apply for a 12 month Postgraduate Placement with an organisation which is relevant to their career pathway or aspirations and programme aims. Alternatively, if a placement has not been secured or student are short of maximum 30 credits, they will have the option to take the Business Transformation module.

Students are responsible for securing their placement through independent applications, with support available from our employability service, MDXWorks. If a suitable placement opportunity has not been identified before the start of the placement module due to unsuccessful applications or unsuitability and students choose not to take the Business Transformation module, they will then be transferred to the non-placement programme title upon successful completion of the Dissertation module.

Before enrolling on the 12 month Postgraduate Placement module, a student will go through an application process and have an initial meeting with a potential employer. They will be interviewed and selected for the role.

During the work placement, the teaching and learning will be around mentoring the students and focuses on work-based learning with the support of the lecturer and MDX works.

#### 15. Future careers and progression

It is envisaged that in year 2 students will have opportunities to work within several sectors of employment that align with the programme aims. They will be prepared for work in the 'Third' or 'Not-for-Profit' sector, national and international NGOs, charities and community groups. Graduates will also be equipped to work at a decision-making level within the overseas development sector, environmental agencies or organisations dedicated to developing countries. Graduates may also seek policy related appointments with national governments, regional bodies and global regulators.

The choice of dissertation provides students with an opportunity to develop additional specialist skills and knowledge in a field they are particularly interested in. For those students intending to further their education, the MA Global Governance and Sustainable Development will equip them with a range of skills required for doctoral-level study.

In the case of the Master's awards, these aims will be realised in full. For earlier exit awards, achievement of the aims will be as follows:

- For the Diploma, all aims stated above, with the exception of completion of Dissertation or Work Integrated Learning outcomes.
- For the Certificate exit award will be achieved at any three compulsory modules of 20 credits each

#### 16. Particular support for learning (if applicable)

- Programme induction workshop will be held in induction week for September or January starts.
- All academics on the programme provide up to 2 hours per week either on campus or on-line on a drop-in basis.
- All academics on the programme can be contacted by e-mail and will endeavour to respond within 3 working days.
- All students who wish to have support with academic writing can access the specialist Learning Enhancement Team (LET) on the Campus.
- Students whose first language is not English can contact the University English Language Centre which offers English language courses (pre-entry) to enable applicants to achieve the required entry score

- Middlesex University Library and subject librarian will provide access to specialist learning resources i.e., journals, textbooks, reports etc. For ease of access for students based at Hendon, the library has facilities for inter-library loans and
