## 9. Criteria for admission to the programme

The University's standard entry requirement is 112-128 UCAS tariff points. However, mature applicants with relevant experience or qualifications, including access course qualifications, are also considered. Other non-UK qualifications will be considered in accordance with NARIC guidelines.

International students who have not been taught in the English medium must show evidence of proven ability in English such as TOEFL grade 550 or IELTS grade 6.0.

For direct entry into year 2 or 3, applicants must have studied LLB modules in a degree in English law which must contain the same core modules studied in the same academic year. Applicants must have passed modules at their previous University at the first attempt (with no resits) with 50% or higher for year 2 entry and 60% or higher for year 3 entry and must have completed full years of study.

University policies supporting students with disabilities apply, as described in the University Regulations 'Information for students with disabilities and learning difficulties.

## 10. Aims of the programme

The programme aims to:

- Provide the student with the level of knowledge and understanding of the principles of law, particularly in the Foundations of Legal Knowledge, and an opportunity to develop the associated transferable intellectual and key skills that will help equip students for the Solicitors Qualifying Exam and the Barristers Training Course.
- Provide the student with a broad academic qualification, which develops the student's understanding of the ethical, social, political, economic, cultural and historical contexts within which law operates.
- Provide the student with specialist law modules enabling students to extend and develop their legal knowledge and understanding in areas of academic or professional interest.
- Develop the skills of legal analysis and encourage an ability to evaluate the law and legal systems and processes.
- Provide a programme of study which is relevant to the legal profession and employers in general and lays the foundations for a successful career.

### 11. Programme outcomes

## A. Knowledge and understanding

On completion of this programme the successful student will have knowledge and understanding of:

1. The fundamental doctrines and principles which underpin the law of England and Wales, particularly in the Foundations of Legal Knowledge- Public Law, Contract Law, Tort, Criminal Law, EU Law (if selected), Land Law, Equity and Trusts.

2. The primary sources of law: case law, legislation and other relevant material including examination of how the laws are made and developed, of the institutions within which the law is administered and the personnel who practise law.

3. A wide range of legal concepts, values, principles and rules of English Law and how to explain the relationship between them in a number of particular areas.

4. The significance of ethical, social, business, political, historical and cultural contexts within which the law operates.

5. The complexities of some substantive areas beyond the Foundations of Legal Knowledge of the legal system.

#### Teaching/learning methods

Students gain knowledge and understanding through workshops, seminars, mini lectures and self-directed study using a variety of resources, including the library and eLearning.

Seminars regularly involve interactive exercises and opportunities for peer and selfassessment. They also provide the opportunity for discussion to address issues covered by workshops, mini lectures and back-up reading. In so doing, they also provide opportunities for students to seek clarification of understanding, and for staff to gather feedback. Seminars therefore reinforce the student knowledge base (outcomes A1-5). The level four modules introduce the essential building blocks of law (outcomes A1 and A2). Workshops on compulsory substantive law subjects are used to immerse students in an overview or framework of the subject matter of the module, to direct students to further study and research and to pose questions in relation to the subject matter being discussed (outcome A1).

Learning and teaching on all Law modules (particularly the option modules) is informed by a critical approach which encompasses relevant aspects of the ethical, social, business, historical and cultural contexts within which the law operates (outcomes A3, A4, A5). Students are encouraged to explore a range of concepts and values and to explain the relationship between them (outcome A3). In particular, ethics are specifically embedded in some modules and students are provided with the opportunity to understand the ethical dimensions within which the law operates at each level (outcome A4).

## Assessment methods

Students' knowledge and understanding is assessed by summative assessments in all modules combining a blend of authentic assessments including moots, presentations, coursework and multiple-choice tests which allow the student to demonstrate a developing and increasingly sophisticated level of knowledge of the relevant subjects. Formative assessments at all levels also reinforce knowledge and understanding. At level four, the principal focus of the summative assessments is on developing knowledge of the relevant basic principles and concepts (outcomes A1, A2, A3). At level five and level six, the focus is on knowledge of substantive legal subjects (outcomes A1, A2, A3), while level six in particular also brings to the fore in-depth, contextual and specialist knowledge of areas of law studied in option modules (outcomes A3, A4, A5).

## B. Skills

On completion of this programme the successful student will be able to:

1. communicate complex ideas clearly and concisely in the appropriate format and to a diverse range of audiences, via proficient written, verbal and visual communication, integrating both traditional and digital communication channels;

2. dissect complex real-life legal problems and derive meaningful insights from various information sources, and approach legal challenges with creative thinking, generate innovative solutions and adapt to evolving situations;

3. demonstrate critical and reflective thinking skills, through an ability to analyse information, reflect on and evaluate different perspectives, and draw balanced and evidence-based conclusions;

4. demonstrate a sustainable mindset, integrating environmental and social considerations into decision-making processes; developing an ability to assess the impact of choices to

real life problems to ensure these are as sustainable as practically possible and contribute to a responsible global community;

5. offer a diverse range of knowledge, behaviours and skills to potential employers, making them valuable assets in the workplace;

6. undertake independent research and identify, retrieve, investigate and manage information from a range of academic sources and from websites to produce up-to-date and relevant information.

7. locate and use primary and secondary legal sources relevant to the topic under study and to reference the sources accurately according to recognised legal conventions;

8. use and apply correct and accurate legal terminology orally in moots and presentations and in writing;

## Teaching/learning methods

Students acquire skills throughout their study on the programme. In particular, the level four modules lay the foundation for many of the skills which are subsequently built on in the specialist law modules. Students are trained in undertaking legal research intensively at level four and then at levels five and six (B6). At levels five and six, directed learning in materials on the VLE and seminars encourage a reflective and critical review of information from academic sources and from electronic resources, including journals (B2, B3, B6). Students are provided with opportunities to develop their oral skills and ability to formulate and present ideas through group discussion and debate in seminars at each level and in workshops. Students learn practical skills through an emphasis on the acquisition of the written and oral legal skills initially in the level four modules and then reinforced at levels five and six (B1, B7). At levels five and six, students are encouraged to act independently and autonomously in planning and undertaking tasks in areas in which they have studied (B3, B4). Some modules at level six in particular provide opportunities to undertake research on specific aspects of the subject which have not been taught (B4, B5). An entrepreneurial mindset and sustainable thinking are embedded into the syllabus in many modules (B4, B5). Resourcefulness is encouraged to enable students to become autonomous learners and practitioners (B4, B5). Creativity is nurtured to encourage students to think 'outside the box' and to be entrepreneurial in their legal arguments (B3, B4).

## Assessment methods

Students' skills are assessed by the summative assessments across the programme. The key skills of effective communicators (B1), analytical and creative problem solvers (B2), critical and reflective thinkers (B3), and a mindset focused on sustainable solutions (B4) underpin the programme as a whole and are assessed in many of the modules. Combined, they aim overall to foster highly employable graduates, potential assets to prospective employers (B5). Problem solving, critical and analytical thought, and effective communication (B2, B3, B1) are assessed at all three levels in a variety of authentic assessments including coursework, reports, presentations and moots. Sustainable solutions to problems of justice in general, and specific legal problems in particular (B4)

are assessed through structured opportunities offered by assessment schemes in some modules. All students are required to undertake research for their assessments by using innovative techniques and methodologies (B2, B3, B6) while adhering to legal conventions regarding validating source material (B7) and using correct terminology (B8).

## **11.1 Employability statement**

The LLB Law Programme is committed to developing students not only academically but also in terms of **employability**, **career understanding**, and **readiness for the future world of work**. Students are equipped with a diverse set of skills to thrive in a rapidly evolving job market. The programme is designed in consultation with industry partners and employers, who help to inform course content and activities. Throughout the programme, opportunities to develop and apply essential skills for professional life are provided. These are the **graduate competencies** summarised below, which demonstrate the links between the programme of study, the modules undertaken, and the typical skills that employers will be looking to see in graduates.

## Graduate Competencies developed within LLB Law

- 1. **Communication, Empathy and Inclusion:** The programme incorporate various communication activities such as moots, presentations, and written assignments. These help students learn to articulate ideas and engage with diverse audiences.
- 2. **Innovative Collaboration:** Collaboration is a cornerstone of our curriculum. All students engage in group projects to creatively support 'real world' law clients including working as a litigation team in moots (mock court cases).
- 3. **Problem Solving and Delivery:** Our programmes emphasise critical thinking and problemsolving skills through hands-on projects, case analyses, and practical exercises. These include solving complex legal problems and analysing and explaining legal issues.
- 4. **Entrepreneurship:** We encourage an entrepreneurial mindset by exploring and identifying creative solutions to legal problems and finding ways for victims to achieve redress, justice and accountability.
- 5. **Resilience and Adaptability:** Our supportive learning environment encourages students to overcome challenges and setbacks, promoting resilience. Through *experiential learning opportunities* such as at our legal advice clinic law students learn to navigate obstacles, manage stress, and adapt during times of adversity. Students are supported through the delivery of a menu of embedded employability interventions tailored towards Law through our Careers and Employability Curriculum.
- 6. **Technological Agility:** In an era of rapid technological advancement and an increasing influence of AI, we prioritise digital literacy. Our curriculum integrates cutting-edge technologies, examples of which include state of the art legal research databases. Through hands-on experience, students are prepared to adapt to emerging technologies and thrive in digitally-driven industries. Upskilling tools are highlighted, including access to platforms like LinkedIn Learning.

- 7. **Curiosity and Learning:** We foster a culture of curiosity through projects and experiential learning opportunities, where students are encouraged to explore new ideas, ask critical questions, and pursue opportunities beyond the classroom. We do this by working closely with a dedicated law specialist in MDXWorks, curated work placement and internship opportunities, and coaching students' networking skills at industry events. These include University wide career fairs but also exclusive Business and Law Faculty Careers Fairs and law-specific events such as pop-up employer events featuring panels with representatives from law firms, corporate legal departments, government agencies and non-profit organisations sharing insights about legal careers, and sustained outreach collaborations with industry employers such as the Law Commission. Our students also benefit from the ability to move to one of our three campuses in London, Dubai or Mauritius and to complete part of their LLB programme abroad, benefiting from another culture without having to extend their studies.
- 8. Leadership and Influence: Leadership development is woven throughout our curriculum, providing students with opportunities to show leadership qualities within group projects and influence others positively, irrespective of formally taking on a leadership role. Practical experiences such as formal employment as Student Learning Assistants and Student Voice Leaders, as well as informal leadership opportunities in classroom activities provide students with a foundation to inspire, motivate, and empower those around them.

## 12. Programme structure (levels, modules, credits and progression requirements)

#### 12.1 Structure of the programme

The LLB (Hons) Law Programme comprises four thirty-credit semester-long modules in each year, structured as two modules per semester. The modules include the Foundations of Legal Knowledge subjects (the **'core modules'**).

## Full-Time LLB Law Three Year Mode:

#### Year One

In the first year, four compulsory 30 credit semester-long modules are taken. English Legal System and Legal Skills are the building blocks of the LLB Programme and taken in Semester 1. In Semester 2, the other two compulsory 30 credit law modules, Public Law and Contract Law, are studied.

#### <u>Year Two</u>

Two compulsory modules are studied in the second year: Tort in Semester 1 and Criminal Law in Semester 2. In addition, students choose one option module from the following list in Semester 1: EU Law or Employment Law or Alternative Dispute Resolution and Legal Ethics (module groups are restricted to a maximum of 16 students selected by the Programme Team) or (in Mauritius and Dubai only) Sports and Entertainment Law. In Semester 2 they choose one option module from the following: UK and European Human Rights Law or Theories of

International Relations or English and International Commercial Law or Rethinking Crime and Justice.

Students are able to give their programme a distinctive character by the choice of options in their second and third years. A choice of English and International Commercial Law or Employment Law in the second year, together with for example, UK Company Law in the third year, will give it a commercial focus, whereas a choice of UK and European Human Rights Law in the second year together with for example, International Human Rights Law in the third year, will shift the focus towards the relationship between the individual and the law.

## Year Three

Two compulsory modules are studied in the third year: Equity and Trusts in Semester 1 and Land Law in Semester 2. In addition, students choose one option module from the following list in Semester 1: Medical Law or UK Company Law or International Human Rights Law or (in Mauritius and Dubai only as a year long module) Advanced Mooting and Advocacy. In Semester 2 they choose one option module from the following: Child and Family Law or Evidence or Public International Law or Global Trade Law or Integrated Learning and Work Placement or (in Dubai or Mauritius only) a Project. Since Advanced Mooting and Advocacy is a year long module running in Mauritius and Dubai only.

## **BA Law Exit Degree**

The Bar Standards Board permits compensation of a single marginal failure in one of the foundations of legal knowledge subjects where the following requirements are satisfied:

- A. The course provider's assessment regulations permit this; and
- B. There are exceptional circumstances in your case that are likely to have impacted on your performance; and
- C. Your mark for the subject to be condoned or compensated is not less than 35%; and
- D. There is evidence of your academic strength across your course studies.

If students do not satisfy the Bar Standards Board criteria for compensation of a foundation of legal knowledge module:

- students who fail a level 4 module in Year 1 will be transferred to BA Law in Year 2 as an Exit Degree.
- students who fail a level 5 core module in Year 2 will be transferred to BA Law in Year 3 as an Exit Degree.
- students who fail a level 6 core module in Year 3 will be required to study additional credits in order to graduate with BA Law as an Exit Degree.

The structure of BA Law as an Exit Degree is as follows:

#### Year 2 (level 5)

Students will study 4 compulsory 30 credit semester long modules: Tort Law and EU Law in Semester 1, and Criminal Law and UK and European Human Rights Law in Semester 2.

## Year 3 (level 6)

Students will study 3 compulsory and one optional 30 credit semester long modules: The compulsory modules are Medical Law and UK Company Law in Semester 1 and Evidence in Semester 2. In Semester 2 the optional module is either Child and Family Law, or Integrated Learning and Work Placement.

- A. The course provider's assessment regulations permit this; and
- B. There are exceptional circumstances in your case that are likely to have impacted on your performance; and
- C. Your mark for the subject to be condoned or compensated is not less than 35%; and
- D. There is evidence of your academic strength across your course studies.

If students do not satisfy the Bar Standards Board criteria for compensation of a foundation of legal knowledge module:

- students who fail a level 4 module will be transferred to BA Law in in the next academic year as an Exit Degree.
- students who fail a level 5 core module will be transferred to BA Law in the next academic year as an Exit Degree.
- students who fail a level 6 core module will be required to study additional credits in order to graduate with BA Law as an Exit Degree.

The Bar Standards Board permits compensation of a single marginal failure in one of the foundations of legal knowledge subjects where the following requirements are satisfied:

- A. The course provider's assessment regulations permit this; and
- B. There are exceptional circumstances in your case that are likely to have impacted on your performance; and
- C. Your mark for the subject to be condoned or compensated is not less than 35%; and
- D. There is evidence of your academic strength across your course studies.

If students do not satisfy the Bar Standards Board criteria for compensation of a foundation of legal knowledge module:

- students who fail a level 4 module will be transferred to BA Law in in the next academic year as an Exit Degree.
- students who fail a level 5 core module will be transferred to BA Law in the next academic year as an Exit Degree.
- students who fail a level 6 core module will be required to study additional credits in order to graduate with BA Law as an Exit Degree.

## 12.3 Non-compensatable modules

## 12.3.1 Compensation for LLB degree

The Bar Standards Board permits compensation on an LLB degree of a single marginal failure in one of the foundations of legal knowledge subjects where the following requirements are satisfied:

- A. The course provider's assessment regulations permit this; and
- B. There are exceptional circumstances in the student's case that are likely to have impacted on their performance; and
- C. Their mark for the subject to be condoned or compensated is not less than 35%; and
- D. There is evidence of academic strength across the student's course studies

### 12.3.2 Compensation for BA Law Exit Degree

The foundations of legal knowledge subjects may be compensated for transfer onto the BA Law Exit Degree programme. BA Law modules may be compensated in line with University Regulations.

#### **13. Information about assessment regulations**

This programme will run in line with general University Regulations.

Award of LLB (Hons) Law degree and professional exemption for the Bar:

There may not be professional exemption for the Bar if:

- A student has taken more than six years to obtain a degree;
- A student is compensated or condoned in a compulsory core module, outside of the allowable compensation in terms of the Bar Standards Board (see 12.3.1).

#### 14. Placement opportunities, requirements and support (if applicable)

Students may choose to undertake a placement year by studying LAW3530 during their third year (or equivalent year in the 4-year part-time mode), and then return to Middlesex for their final year. The Employability Service provides information and guidance on obtaining placements, but students must be pro-active in finding a suitable placement.

Students must complete 240 credits before starting a placement year and obtain the written permission of the LLB Programme Leader. This will only be given if the placement is of sufficient legal standing.

A placement year by studying LAW3530 adds an extra year onto the LLB, which generally has to be completed in six years, so LAW3530 is not available in the 6-year part-time mode.

Alternatively, there is a placement option module available in the final year, LAW3330, which comprises 30 credits and which may be undertaken during the course of the academic year subject to obtaining the written permission of the LLB Programme Leader, which will only be given if the placement is of sufficient legal standing.

## 15. Future careers / progression

Many students pursue studies for the professional qualifications which for solicitors is the Solicitors Qualifying Exam and for barristers is the Bar Practice Course/Barrister Training Course. The LLB complies with the Bar Standard Board's requirements for the academic component of Bar training comprising the seven Foundations of Legal Knowledge as long as students select LAW2110 EU Law as their option module. The LLB also provides a very good basis for the Solicitors Qualifying Exam although an LLB degree is not a requirement for the Solicitors Qualifying Exam. The Solicitors Qualifying Exam will ask students to demonstrate the knowledge set out in the Statement of Legal Knowledge which includes the seven Foundations of Legal Knowledge in addition to other areas of law and practice.

Graduates also study for Master's degrees, sometimes before pursuing the professional exams. Graduates also find employment in a wide range of other careers, for example, business, management, administration as well as other fields. The degree also enables students to gain employment and/or further develop their careers in areas including paralegals, legal executives, academia, in-house lawyers for legal departments of companies/government, legal consultants and community advisory work.
